- c. Exchange of Faculty and students on mutual consent. Each institute will try to provide local hospitality support unless otherwise specified.
- d. Undertaking research and consulting activities jointly for Govt. of Assam and North Eastern States.
- e. Organizing joint activities like conferences and seminars.
- f. Financial details regarding any joint activity will be mutually decided and separately agreed upon.
- g. Any other activity of mutual interest.

#### **SPECIAL PROVISIONS**


1. Both parties shall disseminate information on each-others' programs and activities.
2. Details of the program components and financials for each program will be designed as a case to case basis.
3. Both parties agree to do their utmost to ensure the smooth and efficient implementation of the Program.
4. Both parties shall exert their best effort to be available for mutual consultation and shall give each other necessary information whenever reasonably requested.
5. Any amendment to this Memorandum of Understanding shall be made in writing and mutually agreed upon.
6. All disputes arising in connection with the interpretation or application of this Memorandum of Understanding shall be settled amicably through mutual negotiation.
